Discussion Questions

- 1. From your perspective, was the United States' decision to move the embassy to Jerusalem constructive in the pursuit of peace or does it complicate the process in an unnecessary way?
- 2. Why has the status of Jerusalem been a contested issue for so long?
- 3. Throughout history, many have fought long wars and shed blood over the right to control Jerusalem. Given this fact, what does this teach us about the importance of sacred space in imbuing meaning in the lives of others? How can we uphold a right to sacred spaces while mitigating conflict as much as possible?
- 4. Although Israel does not have a constitution, it does have a list of basic laws. One of these is the Jerusalem Law of 1980, in which Israel declared "Jerusalem, complete and united, is the capital of Israel. Considering that Israel already declared Jerusalem as its capital decades before the United States formally





recognized this, why is it important to Israelis for the United States government to recognize this?
